## 1. INTRODUCTION

---

VIG Group ("we", "us" or "VIG Group"), is a company registered and headquartered in Mauritius and regulated by the Financial Services Commission ("FSC") and holds an Investment Dealer (Full Service Dealer, Excluding Underwriting) License No: GB20026165, governed by Section 29 of the Securities Act 2005, Rule 4 of the Securities (Licensing) Rules 2007 and the Financial Services (Consolidated Licensing and Fees) Rules 2008.

Our business is built on integrity and transparency, offering an industry-leading combination of dynamic products, competitive trading conditions and dedicated support to both traders and affiliates.

It is VIG Group's mission to facilitate access to a wide range of derivative instruments in a regulated environment, supported by robust trading infrastructure and client service.

## 2. COMMITMENT

---

VIG Group is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. VIG Group will only use your personal information in accordance with this Privacy Policy and otherwise in accordance with the relevant personal data protection regulation in Mauritius as amended from time to time.

## 3. VIG GROUP COLLECT PERSONAL INFORMATION

---

VIG Group collects certain personal information in order to meet its regulatory obligations and to provide services to its clients. The information collected enables us to facilitate account establishment, verify client identity, and maintain the client relationship in compliance with applicable laws and regulations.

In addition, this information assists us in monitoring and improving the services we provide.

## 4. WHAT INFORMATION DOES VIG GROUP OBTAIN?

---

VIG Group collects and holds information that you provide when completing an online application, submitting forms or using our services, including accessing and operating your account through our website or other platforms we make available. VIG Group may also derive information generated from your use of our website and related services. This may include details such as:

- Areas of the site visited and pages viewed;
- Frequency and duration of visits;
- Types of transactions conducted;
- Documents accessed or downloaded; and
- Referring websites or links followed to or from our site.

## 5. HOW WILL VIG GROUP USE THIS INFORMATION?

---

VIG Group may use your personal information for any one or more of the following purposes:

- to provide the services to you that you have requested, including processing transactions;

- to verify your identity and conduct necessary due diligence checks;
- to establish, maintain and manage your client profile and account;
- to contact you when necessary or appropriate in relation to the services being provided to you;
- to keep you informed about account activity and relevant updates relating to our services;
- to manage and administer the services made available to you;
- to provide you with information about our services and, where permitted by law and subject to your marketing preferences, other services that may be of interest;
- to tailor our website and platforms to better reflect your needs and interests; and
- to generate anonymised statistical data to help us improve our services.

By engaging with us, you consent to VIG Group using your personal information for the purposes set out above. You also consent to VIG Group transferring your personal information outside Mauritius, where this is necessary for VIG Group to fulfill its contractual obligations to you. Any such transfers are carried out only where VIG Group has ensured that the recipient organisation maintains appropriate safeguards to protect your personal information in accordance with applicable data protection laws.

#### **6. WHO MAY VIG GROUP DISCLOSE THIS INFORMATION TO?**

---

VIG Group may be required to provide your personal information to the regulator and government bodies from time to time. VIG Group may also disclose your personal information to:

- financial institutions and other similar organisations that deal within the course of its corporate activities, or those that are nominated by you;
- external service providers and professional advisers (which may be located overseas) that provide services to VIG Group;
- any organisation at your request or any person acting on your behalf, including your financial adviser, broker, solicitor or accountant;
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom VIG Group is required to disclose such information by law. Please note that VIG Group does not sell or provide your personal information to third parties for marketing purposes.

#### **7. UPDATING YOUR INFORMATION**

---

You may inform VIG Group at any time that your personal details have changed or that you wish VIG Group to delete personal information we hold about you by emailing us at [support@vantagemarkets.com](mailto:support@vantagemarkets.com). VIG Group will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

## 9. COOKIES

---

VIG Group uses cookies to gather information about your access to this website and other services we provide to you. Cookies are small pieces of information which use a unique identification tag and are stored on your device as a result of you using this website or other services we provide to you. When cookies are used by us, they collect statistical information about how you use our services. Most internet browsers are set up to accept cookies. If you do not wish to receive cookies, you may be able to change the settings of your browser to refuse all cookies or to have your computer notify you each time a cookie is sent to it and thereby give yourself the choice whether to accept it or not. However, this may impair the quality of the services that we provide to you in relation to your account.

## 10. SECURITY

VIG Group takes security very seriously and adopts industry and information security best practices to protect your personal information and ensure it is not accessed by unauthorised people. Measures include encryption of data during transmission, strong authentication mechanisms and secure access to machines and data.

## 11. WHAT ARE YOUR RIGHTS?

You need not give us any of the personal information requested by VIG Group. However, without that information, VIG Group may be unable to open an account for you, where the information is requested in an application form, or to provide you with any other services, information or assistance you have sought. Should you have any questions or complaints about your privacy, please contact us. If a complaint is not resolved by VIG Group to your satisfaction, you may complain to the Information Commissioner.

Under data protection legislation, you have (subject to certain exceptions) the right to obtain copies of any personal information which VIG Group holds about you and to inform VIG Group of any inaccuracy.

If you have a request, please contact us to obtain a subject access request form.

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested.

## 12. YOUR CONSENT

By accessing this website or other services we provide to you, you consent to VIG Group collecting, maintaining, using and disclosing personal information about you and provided by you or by another person as described above.

## 13. AMENDMENTS TO POLICY
